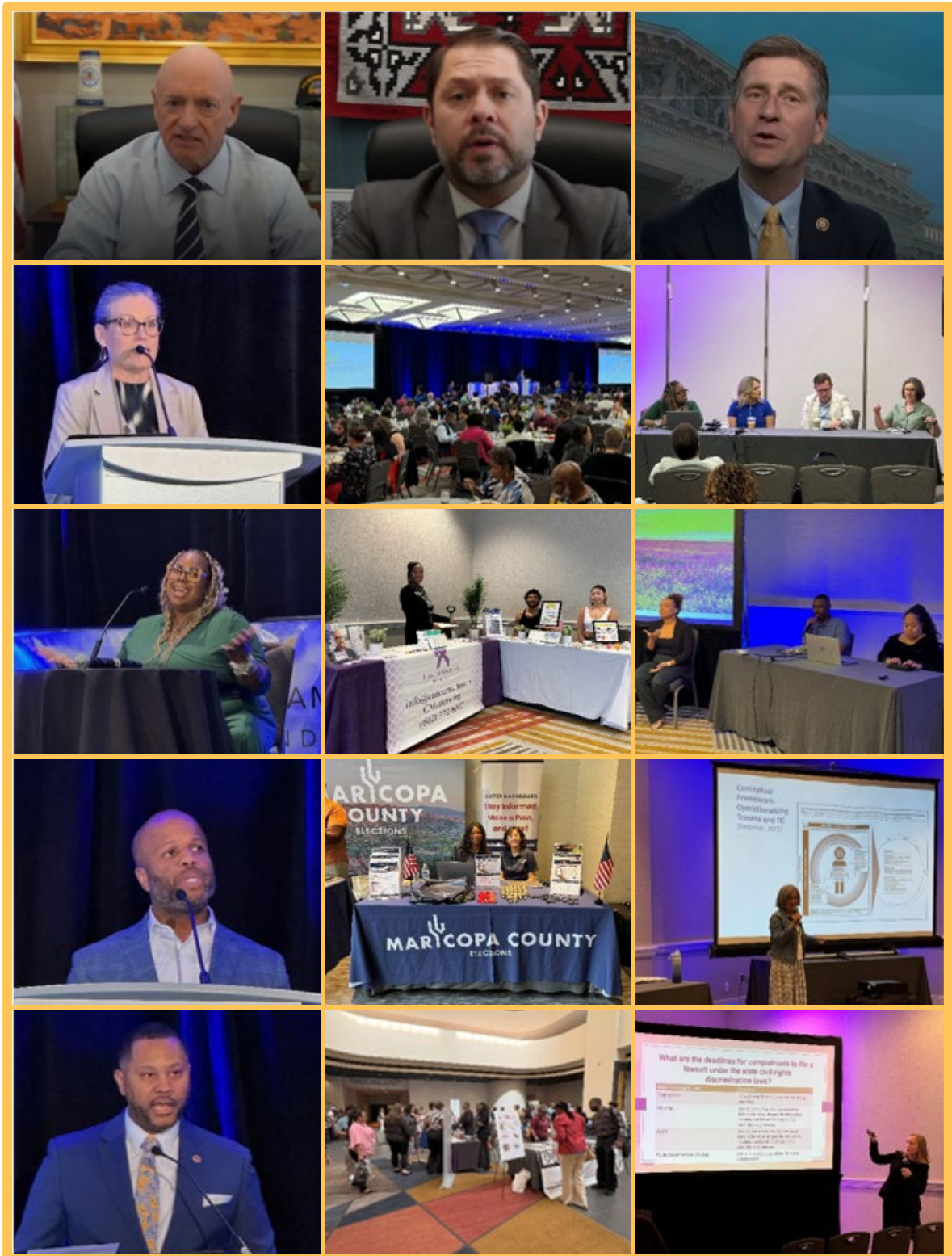

Corey Woods was elected mayor of Tempe in March 2020 and serves as Executive Director of Community Relations at ASU Preparatory Academy. Nationally, he is Vice Chair of the U.S. Conference of Mayors' Housing and Community Development Committee and Co-Chair of the National League of Cities' Housing Supply Accelerator.

As a former Tempe City Council member (2008–2016), Woods championed affordable housing, community development, and human rights.

Recognized as the Arizona Housing Coalition's 2022 Advocate of the Year, Woods is also a strong proponent of climate resilience.

Closing Keynote Speaker: The Honorable Katie Hobbs, Governor of Arizona



Born and raised in Arizona, Governor Hobbs has spent her life exemplifying hard work and public service. After putting herself through college at both NAU and ASU, she began her career as a social worker, working with homeless youth and later helped run one of the largest domestic violence shelters in the country. After seeing her fellow Arizonans continue to struggle with little action from the government, Governor Hobbs decided to take matters into her own hands and run for office.

After being elected to the Arizona House in 2010, Governor Hobbs went on to service in the Arizona State Legislature for four terms. In 2018, she was elected Secretary of State, where she successfully oversaw a contentious election cycle and forcefully defended the votes and voices of every single Arizonan. Governor Hobbs made the decision to run for Governor, and in 2022 was elected the fifth woman, and also the fifth Arizona native, to the state.

Governor Hobbs see her role in Government as a continuation of her social work. In her first term, she, has already moved the needle forward on some of our state's most critical issues. Governor Hobbs approaches every situation and every challenge with a desire to make people's lives better and give every Arizonan an opportunity to thrive.

Workshop 1: Police Interactions and the Disability Community: An Examination on Past Problems and Discussions on Moving Towards a Collaborative and Just System

Sey explored best practices tailored to various types of police interactions, emphasizing the importance of communication, de-escalation, and awareness. He gave attendees collaborative strategies aimed at fostering more informed, respectful, and inclusive encounters between law enforcement and the disability community, underscoring the need for continued advocacy and education.

Workshop 2: Chronic Health Symposium - Session 1 Sickle Cell Patient Population and Clinic Processes

The panel discussed the unique needs of the sickle cell patient population and the importance of effective clinic processes in delivering quality care. They highlighted critical care approaches and the essential role nurses play in advocating for and supporting these patients, emphasizing their expertise and compassionate presence, while emphasizing the importance of newborn screening and timely follow-up.

Workshop 3: Building Bridges for Our Community: Improving Access to Mental Health Providers of Choice

Buffy shed light on the urgent need for accessible mental health services within the African American community and the five major barriers that continue to hinder care—stigma, lack of culturally competent providers, financial limitations, limited access, and mistrust of the healthcare system. She introduced a practical model for navigating these challenges, emphasizing the importance of community education around levels of care and interventions to better provider collaboration.

Workshop 4: Artificial Intelligence (AI) in the Workplace: Friend or Foe?

The panelists discussed how AI-driven pre-screening tools can unintentionally disadvantage candidates with disabilities and other protected classifications, raising important concerns around fairness and accessibility. Lindsay answered questions on how AI can offer innovative assistive technologies and resources to support workplace accommodations. The panelists provided a balanced overview of legal protections and inclusive approaches to using AI in hiring and employment practices.

Workshop 5: Addressing the Need for and the Challenges to Develop a Collaboration Mindset within the Black Community

Roy and Matthew spoke passionately about how African Americans possess immense economic power and potential. Through love, faith, and righteous action, they emphasized how Black communities have historically overcome systemic barriers—and how continued collaboration can lead to true freedom and justice. The discussion left many attendees inspired to take action and build stronger, united efforts for change.

Workshop 6: School Discipline in 2025: Educator and Attorney Perspectives

Dr. Chapman shed light on how students of color and those with disabilities face disproportionate school discipline, often with lasting negative effects. Amanda shared practical strategies, legal insights, and discussed recent federal policy changes, underscoring the need for fairer, more supportive practices.

Participants for the topic both eye-opening and deeply informative. The panelist highlighted the troubling reality that parents with disabilities are disproportionately referred to child welfare services and often face permanent separation from their children. They discussed key federal legal protections, including recent disability discrimination findings by the U.S. Department of Justice against the Department of Child Safety. The workshop emphasized the need for reasonable accommodations during proceedings to ensure fairness and equal opportunity. Practical tips and resources were also shared for attorneys advocating for these parents. The session concluded with thoughtful ideas on how Arizona can improve its child welfare system to better support and protect the rights of parents with disabilities.

Workshop 8: Chronic Health Symposium – Session 2 It Takes Everybody to Overcome a Life of Sickle Cell Disease Challenges

The panel discussion provided meaningful insights into tools for self-advocacy, helping individuals with sickle cell disease and their families better navigate healthcare and support systems. “A Vision of Resilience” was especially inspiring, highlighting stories of strength and perseverance within the sickle cell community. Additionally, attendees learned about Arizona’s Sickle Cell Data Collection Program emphasized the importance of accurate data in shaping policy, improving care, and addressing disparities. The panelists reinforced the values of advocacy, resilience, and community-driven efforts in improving outcomes for those affected by sickle cell disease.

Workshop 9: Designing a Trauma-Informed Curriculum: Focus on Safety, Empowerment, and Application

Attendees were treated to valuable insights into the critical need for trauma-informed care (TIC) tailored to individuals with intellectual and developmental disabilities. The panelists walked through the thoughtful curriculum development process, highlighting how trauma can uniquely impact this population. They explored effective training strategies and key topics essential for delivering accessible, inclusive, and meaningful content. Lynne emphasized the importance of collaboration across organizations and clinical settings to successfully integrate TIC principles. They left attendees with a deeper understanding of the prevalence of trauma and how person-centered, healing-focused approaches can significantly improve care and support outcomes.

Workshop 10: Empowered Through Connection: How Belonging Strengthens Emotional Autonomy

Carlian gave a powerful and moving experience for attendees and explored the deep connections between identity, resilience, and the sense of belonging, all grounded in trauma-informed and culturally relevant insights. Through her heartfelt storytelling and meaningful reflection, she examined how emotional autonomy can be reclaimed by connecting to self, family, culture, and faith. Carlian shared practical strategies that offered not just pathways to healing, but to thriving—empowering the Black community to rise above systemic challenges with strength and unity.

The youth panelists gave the audience a truly inspiring and thought-provoking workshop. They shared their personal experiences, that gave attendees a deeper understanding of how disability and other aspects of diversity shape self-perception and identity. Their honesty and insight highlighted the importance of embracing one's full identity with pride and resilience. The panel also offered empowering strategies for managing bias and celebrating diversity in all its forms. It was a powerful reminder of the strength that comes from self-acceptance and community, and the importance of lifting up young voices in the disability advocacy space.

Workshop 12: Chronic Health Symposium – Session 3 Sickle Cell Disease: Shattering Stigma

The panelists emphasized the vital role community health workers play in bridging gaps in care, providing culturally responsive support, and advocating for patients living with sickle cell disease. Equally powerful was the listening session, which centered on hearing individual attendees tell their stories on how they were directly impacted, reminding us how essential it is to create spaces where their experiences guide improvements in care. The workshop was a meaningful reminder that community-led solutions are key to driving lasting change.

Workshop 13: Everything You Need to Know About Handling Discrimination Complaints Before the Arizona Attorney General's Civil Rights Division

Natalie and Rose clearly explained the fundamentals of filing discrimination complaints, including how to file, important deadlines to keep in mind, and the types of cases the Division typically accepts. Attendees appreciated the detailed overview of what happens after a complaint is filed, as well as the different resolution options like mediation and conciliation, and best practices to file complaints.

Workshop 14: Empowering Parents: Bridging the Gap Between Schools, Healthcare, and Disability Rights

Natassia and Madisyn reviewed key laws—including the IDEA, Section 504, the ADA, and relevant Arizona statutes—highlighting the responsibilities schools have in meeting students' medical needs. The session reinforced the importance of collaboration between schools, families, and medical professionals to ensure students receive the support they need to thrive in their education.

Workshop 15: Black Deaf Individuals in the Black Hearing Community

Bibi shed light on the unique experiences and challenges faced by Black Deaf individuals, particularly within their own cultural community. She emphasized the importance of recognizing and valuing diverse modes of communication, and the need for collaboration to bridge gaps in understanding and inclusion. Attendees appreciated the power of shared knowledge to create more connected communities.

Workshop 16: Your First Steps to Building Your Credit

Branislav explained to attendees how credit works, by breaking it down into the basics, and why it plays such a crucial role in our financial health—from qualifying for loans to securing better interest rates. He appreciated questions from attendees asking how to build credit responsibly and how to monitor and manage it over time. Workshop participants left feeling more confident and better equipped to take control of their financial future with a better understanding of credit.

Workshop 17: How Do We Manage Our Trauma Triggers? Veterans and Civilians Speak Out

Dr. Danita Applewhite’s workshop was both powerful and deeply moving. Attendees were struck by how she connected the historical trauma of Post Traumatic Slave Syndrome (PTSS) with the modern-day experiences of PTSD, especially in professional and educational settings. She shed light on the unique challenges African American men and women face and how these traumas shape our responses to social and disability justice issues. Dr. Applewhite’s compassionate and knowledgeable approach gave attendees the tools to manage triggers more effectively.

Workshop 18: Chronic Health Symposium – Session 4 Introducing 360 (SCD) Sickle Cell Disease

Attendees enjoyed the panelists’ unique perspective on sickle cell disease and gene therapy, from explaining the basics of gene therapy to discussing the real-life transitions patients face while living with sickle cell. Lisa led conversations and gave insights on the complications children experience and how treatments are evolving. She also discussed Bluebird Bio’s advancements in gene therapy that give hope for the future—especially for families affected by sickle cell disease.

Attendees found the workshop on accessing behavioral health services in Arizona was incredibly helpful and empowering. The team presented data on issues people with intellectual and developmental disabilities (IID) and their supporter have in navigating the system more effectively and how crucial self-advocacy and peer support are for individuals with people with IID who need behavioral health care. The workshop was interactive and practical—as the panelists gave real-life scenarios and left attendees feeling more equipped to support themselves and others in advocating for the care we deserve.

The discussion also shed light on the unique challenges faced by the African American community, which resonated with the attendees. It was a thoughtful and necessary conversation that left attendees feeling more prepared and informed about the aging throughout their lifespans.

Hearing from members of the National Federation of the Blind and SAAVI Services for the Blind informed the attendees on the strength and capability within the blind community. The message was clear: leadership should reflect diverse voices and lived experiences. Attendees left the session feeling motivated to rethink how to define leadership and become more committed to supporting inclusive spaces where everyone can thrive.

The panelists provided eye-opening and thought-provoking insight into the real challenges officials face when trying to uphold fair and secure elections amid growing political division. What stood out most was the intersectional approach—connecting systemic injustice, social inequality, and the vital role of grassroots advocacy. The panelist helped attendees see how legal and policy decisions impact marginalized communities and reinforced the importance of staying engaged and informed in the fight against discrimination in our democracy.

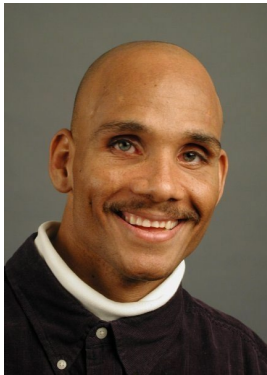
